The Quarry Safe Competence Assessment is a comprehensive assessment based on the National Occupational Standards (NOS) comprising of an observation of skills, a multiple-choice test of knowledge, a consideration of training & experience and a discussion of other qualities.

The QSCA© is designed to be a robust and rigorous assessment of competence.

For each QSCA© category successfully completed, employers receive a 'Certificate of Competence', and drivers/operators receive an ID/Operator card, confirming assessment and competence, which is valid for 3 years.
